GROUND RULES AT CAMP ROBINSON:

1. All horses must be accompanied by proof of a negative Coggins test that is current within the past 12 months.
2. No staking out of dogs unless all kennels are full.
3. No staking of horses or dogs in the inner camping area due to electric and water lines. Use area outside of the inner camping area.
4. No stock trailers allowed in the inner camping area.
5. Please fill holes and pick up your trash.

CAMPING

Overnight camping is allowed on the dog trial grounds. There are limited sites with electrical hook-ups. No dogs or horses may be staked out in camping area.

NOTE TO TRIAL PARTICIPANTS AND VISITORS

Please use designated areas for camping and parking. Exhibitors are expected to clean up after themselves and their animals. This includes filling in any holes their dogs/horses create, spreading/removing horse manure, removing leftover hay, picking up/removing dog waste and generally cleaning up their camp area before leaving. Those who fail to do so may be charged a \$100 clean-up fee and denied entry to future events. All participants, guests and entries are accepted on the condition that the NWA, its officers, members, officials and volunteers, Camp Robinson and its members are released from liability for loss, damage or injury sustained by people, dogs or horses in connection with or during the trial.

Coming from Little Rock take exit 135 for AR-89, in 4.5 mi turn left onto Clinton Rd, continue 3.2 mi to 331 Clinton Rd.

Coming from the West take exit Exit 135 for AR-89, in 4.5 mi turn left onto Clinton Rd, continue 3.2 mi to 331 Clinton Rd. This bypasses all travel through the city traffic.
